Note: **Cooling off period: Students are able to change their mind and cancel their intended training. A cooling of period of 3 business days applies from the date they complete and sign their enrolment documentation.**

- 1 Fees are valid for enrolments commencing 1/01/2025 and subject to change given individual circumstances at enrolment.
- 2 The material fee includes only the materials that are provided to you by the Skilled Up and excludes the reading material provided as a part of course resources.
- 3 Skilled Up does not charge any student services and amenities fee to its students.
- 4 The student must be eligible for Skills First Funding to receive a Victorian Government Subsidised fee.
- 5 Students who meet government Skill First program training criteria, enrolment and material fee needs to be paid where applicable
- 6 Concession Fee is only valid for the eligible candidates enrolling in the course at Certificate IV level and below, who hold one of the following prior to commencement of training.
 - a. Health Care Card issued by the Commonwealth
 - b. Pensioner Concession Card; or
 - c. Veteran's Gold Card; or
 - d. an alternative card or concession eligibility criterion approved by the Minister for the purposes of these Guidelines.
- 7 Individuals of Indigenous descent are eligible for the concession fee irrespective of the level of the qualification
